A community foundation is a not for profit organisation dedicated to improving a local community by addressing community needs and supporting local causes.

New Zealand's community foundation movement began in 2003, with the support of The Tindall Foundation. There are currently 17 community foundations supporting philanthropic activities around New Zealand, covering over 80% of the country.

While relatively new to New Zealand, the concept of pooling and investing charitable donations for the good of a local area has been a growing global movement for over a hundred years. In the United States, community foundations have proven to create long-lasting positive transformation in communities worldwide.

We pool and invest the charitable gifts of donors, with the income earned going back to local community causes while the original investment continues to grow over time.
